Note: Corporate Membership applies to individual offices only. Meeting costs (with the exception of the annual event) are \$25.00 for Members and \$30.00 for Non-Members. Please attach a Membership Application for each member with this form.

Regular Members shall certify that they shall have, within the most previous twelve month period, completed a minimum of one commercial transaction and have earned a Gross Commission Income of at least Five Thousand Dollars (\$5,000) in commercial real estate transactions subject to verification.

Associate Members: "... shall consist of allied professionals whose input will aid in the promotion of the organizations objectives." Applicant's will be reviewed and approved by the Board of Directors on an individual basis. Associate Members are encouraged to sponsor the MAREMA Annual Meeting.

Apprentice Members shall be individuals not having experience in the field of commercial real estate; however, are desirous of learning the trade through exposure and participation in the work sessions of the monthly meetings, and are highly encouraged upon acceptance to membership to enroll in the formal educational programs offered by MAREMA.
